



Warranty Statement

Limited Warranty

USA LawnShark Manufacturing LLC. (LawnShark) warrants LawnShark product to the original purchaser to be free from defects in material and workmanship from the date of purchase for the warranty period of the product as set forth below:

1 Year Warranty: LawnShark equipment, for one (1) year from the purchase date for the original purchaser's LawnShark equipment. LawnShark will replace, through an authorized LawnShark dealer, free of charge, any part or parts found upon examination by the Original Equipment Manufacturer, to be defective in materials or workmanship or both.

90 Day RENTAL Warranty: LawnShark equipment, for ninety (90) days from the purchase date for the original purchaser's rental use. LawnShark will replace, through an authorized LawnShark dealer, free of charge, any part or parts found upon examination by the Original Equipment Manufacturer, to be defective in materials or workmanship or both.

Batteries: have a one (1) year prorated limited warranty with 100% replacement during the first 6 months.

Items not covered by this Warranty

The following items are not covered by this warranty:

- Labor
- Normal customer maintenance items which have become worn through normal regular use, including, but not limited to, clutches, pulleys, belts, discharge tube, debris bags, springs, switches, filters and spark plugs;
- Natural discoloration of materials caused by ultraviolet light;
- Engine and drive systems not manufactured by LawnShark; these items are covered under the respective manufacturer's warranty as provided in writing with the product information supplied at the time of purchase; all claims must be sent through the an authorized LawnShark dealer;
- Brush decks and frames with sand abrasion;
- Emission Control System components necessary to comply with CARB-TIER II and EPA regulations which are manufactured by third party manufacturer.

Limitations and Exceptions:

This warranty shall be inapplicable to defects resulting from the following:

- Abuse, misuse, accident, negligence and neglect, including rust, corrosion, moisture, abrasives, dirt, stale fuel, or any adverse reaction due to incorrect storage or use habits;
- Failure to operate or maintain the unit in accordance with the Owner's/Operator's manual;
- Alterations or modifications that change the intended use of the product or affects the products safety, operation, performance, or durability, or causes the product to fail to comply with any applicable laws;
- The use of replacement parts other than genuine LawnShark parts; or
- Additional damage to parts or components due to continued use occurring after any of the above.

Customer Responsibilities:

The product must exhibit reasonable care, operation, maintenance, storage and general upkeep as written in the Owner's/Operator's manual. Should an operation problem or failure occur, the product should not be used, but delivered as is to an authorized LawnShark dealer for evaluation. Proof of purchase rests solely with the customer.

Procedure to obtain warranty consideration:

It is the Owner's responsibility to make certain that the Warranty Registration Card is properly completed and mailed to USA LawnShark Manufacturing. This card shall be mailed within ten (10) days from the date of purchase in order to confirm the warranty and to facilitate post-sale service.

Proof of purchase must be presented to the authorized LawnShark dealer in order to obtain warranty service. This proof must include date purchased, serial number, model number, and complete name and address of the selling dealer.

To obtain the benefit of this warranty, the defective product must be delivered, at the owners expense, to an authorized LawnShark dealer in a timely manner, no later than thirty (30) days from the date of the operational problem or failure. Downtime, pick-up and delivery charges are not covered by this warranty.
